Due to the recent Merge with Bedford Hospital, the IT department's strategy and plans for the new organisation is under review.

- 2.ICT Org Chart- A visual document that present the structure of the IT department, please include name and job titles. If this can't be sent please work towards a structure with job titles. Currently unavailable.
- 3.ICT Annual or Business Plan- Similar to the ICT strategy but is more annually focused.

  Due to the recent Merge with Bedford Hospital, the IT department's ICT Annual or Business Plan for the new organisation is under review.
- 4. ICT Capital Programme/budget- A document that shows financials budget on current and future projects.

Due to the recent Merge with Bedford Hospital, the IT Capital Programme Budget for the new organisation is under review. Some of the projects in progress are N3 to HSCN, Finance Service Line Reporting, CMIS Upgrade and some of the scheduled projects are Diamond.Net Letters to Evolve and Networked Devices. These project budgets could be anywhere between 20,000 to 80,000 Pounds.
