The first consideration for most people when writing their Will, is their family and close friends and then perhaps a charity close to their heart.

Did you know that the L&D was first built thanks to a local grocer who left a generous gift in his Will? Legacies continue to have a positive impact on patients and their families to this day.

The Coronary Care Unit was totally redeveloped after benefitting from a significant legacy; a legacy of £60,000 bought the Neonatal Intensive Care Unit a desperately needed incubator and ventilator; a generous gift was also recently left to the Macmillan Cancer Unit and this has been used to refurbish the whole unit and Chemotherapy Suite.

## The importance of having a Will

- **Looking after your family** Writing a Will is the only way to make sure your wishes are carried out after you die.
- **Looking after others** You can decide who you would like to receive a gift. Whether it's family, friend(s) or a charity, you can decide exactly what you would like them to receive.
- **Reduce inheritance tax** Gifts to registered charities, such as the L&D charitable fund, are exempt from inheritance tax and may reduce the rate of tax to be paid on the assets of your estate.

The beauty of writing a Will is that you can include everyone you want to... you get to make the decisions and plan for the future.

If you die without a Will the law determines who takes your possessions.

## Next Steps

We strongly recommend using a solicitor when making or updating your Will to ensure everything is legal. If you already have a Will you can easily add to it or make a change by using a Codicil. This is usually quick and inexpensive.

## Types of gifts

**A share of your estate** After you have provided for your family & friends, you can leave a share of what remains to charity. This is known as a 'residuary gift'.

**A cash gift** This is when you leave an exact sum of money. It's known as a 'pecuniary gift'.

**A gift in trust** You can leave a gift for someone to use over a period of time. When the time has ended, the gift can be passed on to other recipients, such as a charity.
